ON-SITE ENTRIES: On-site entries will be accepted according to the deadlines indicated on the entry forms. Teams registering onsite must bring current league stats or be on LeagueSys – no exceptions.

REFUND REQUESTS: Must be submitted in writing and received by Nov 24, 2015. All refunds will be charged a \$10 handling fee and processed after Dec 14. Registration and late fees are non-refundable.

SCOTCH DOUBLES

Begins Thur, Dec 3 @ 12pm / \$750 added (based on 64 teams)

Eligibility: Must meet one of the following criteria

1. Be a BCAPL or USAPL League player with 4 weeks of sanctioned play between June 1, 2015 and Dec 1, 2015
2. Be a CSI Associate Member

Format: 8-Ball, double elimination, alternate break, rack your own. Each team may only have only one player rated as Advanced or Master with the other ranked as Open or Leisure. A CSI Associate Member must play with a league-qualified player. Both players must come from the same state.

Races: Race to 3 for Open/Open or Open/Leisure teams. Race to 4 for teams with one player rated as Advanced or Master.

SINGLES

9-Ball Singles Mini's: Begins Wed, Dec 2 @ 7pm & Fri, Dec 4 @ 8pm / Single elimination / \$125 added to each (based on 32) / Race to 3

Men's Singles: Begins Fri, Dec 4 @ 4pm / \$750 added (based on 64)

Women's Singles: Begins Fri, Dec 4 @ 4pm / \$750 added (based on 64)

Eligibility: Must meet one of the following criteria

1. Be a BCAPL or USAPL league player with 4 weeks of sanctioned play between June 1, 2015 and Dec 1, 2015
2. Be a CSI Associate Member

Format: Double elimination, alternate break, rack your own.

Men's Teams: Begins Sat, Dec 5 @ 4pm
\$750 added (based on 32 teams)

Women's Teams: Begins Sat, Dec 5 @ 4pm
\$750 added (based on 32 teams)

Eligibility: Must be a BCAPL or USAPL League player with at least 4 weeks of sanctioned play between June 1, 2015 and Dec 1, 2015.

Format: 8-Ball, double elimination

Team Rosters: Men's Teams are 4-player and Women's Teams are 3-player with a max of 6 or 5 players listed on the roster. Players may only be listed on one team roster. Each team may have a mix of players rated as Leisure, Open, Advanced, and Master but may only have (1) Master or (2) Advanced players listed on the team roster. Open level players must come from the same league. Advanced and Master players must come from the same state as the team. Matches are handicapped and based on the below point system.

Men's Team Races:

The Men's Teams minimum race is 8 and maximum race is 10 based on the combined points of the 4 players who compete in that match.

Women's Team Races

The Women's Teams minimum race is 6 and maximum race is 8 based on the combined points of the 3 players who compete in that match.

Leisure or Open Player = 2 pts

Advanced Player = 3 pts

Master Player = 4 pts

Substitutions: Teams may sub players after the first round. The sub must be of the same or lower level rating as the person being replaced. The team race number remains the same as determined by the initial team lineup for the match.
