ENTRY FEE and PAYMENT:

NOTE: All mailed and faxed entries must include a completed and signed entry form. Entry form information must be typed or printed neatly. Entries will be returned if illegible or not complete.

IMPORTANT DEADLINES: Late fees begin August 4. All mailed entries must be postmarked by August 10th, and received no later than August 17th. Online and faxed entries must be received by August 31st.

ON-SITE ENTRIES: On-site entries will be accepted according to the deadlines indicated on the entry forms. Teams registering onsite must bring current league stats or be on LeagueSys – no exceptions.

REFUND REQUESTS: Must be submitted in writing and received by August 24, 2015. All refunds will be charged a \$10 handling fee and processed after September 21st. Registration and late fees are non-refundable.

DRESS CODE: This event follows dress code C

The following applies to A, B & C Dress Codes:

Footwear - All footwear must have a closed toe and be normal in the manner of its style and wear. Shoes with laces must have the laces properly tied (closed toes shoes required at all events).

Hats - Billed or brimmed hats or caps that are clean and neat. All hats must be worn in the manner in which they are intended to be worn. Applicable to all dress codes is that all apparel must be neat, clean, un-torn and tasteful.

Details of Dress Code C: Dress Code C may be used at BCAPL State and Regional events. The event administrators may elect to use Dress Code C. Matching team shirts are not required. Business casual shorts and T-Shirts are allowed.

DIVISIONS and ELIGIBILITY:

Scotch Doubles: Limited to 64 Scotch Doubles Teams. Begins Thursday, Sept. 3 at 7 pm. Finishes Friday or Saturday (depending on size of field).

Added: \$500 (Based on full field)

Eligibility: Open to BCAPL and USAPL League Players with 4 weeks of sanctioned play between June 1 and August 28, 2015 or who were eligible for the 2015 BCAPL/USAPL National Championships.

Format: 8-Ball, double elimination, alternate break, rack your own. Each team may only have one Advanced or Master player with the other ranked as Open or Leisure. A CSI Associate Member must play with a league-qualified

player. CSI Associate Members with no CSI performance record will be considered Advanced. Both players must come from the same state. Race to 3 for Open/Open or Open/Leisure teams. Race to 4 for teams with an Advanced or Master player.

Singles:

General Eligibility: Open to BCAPL and USAPL league players with 4 weeks of sanctioned play between June 1 and August 28, 2015 or who were eligible for the 2015 BCAPL/USAPL National Championships. CSI Associate Members must play as Advanced / Master level unless known ability demonstrates otherwise, which is researched and determined by CSI staff.

NOTE: All singles divisions are 8-Ball, double elimination, alternate break, rack your own.

AZ ONLY 6 & Under Singles:

Begins Friday, Sept. 4 at 12 Noon / \$500 Added / Limited to 128 players
Format: Race to AZ Handicap -1

Men's Singles:

Begins Friday, Sept. 4 at 7 pm / \$500 added based on 64 players

Women's Singles:

Begins Saturday, Sept. 5 at 10 am / \$500 added based on 32 players

RACES:

Leisure:	Men (4)	Women (3)
Open:	Men (5)	Women (4)
Advanced:	Men (6)	Women (5)
Master:	Men (7)	Women (6)

Teams:

General Eligibility: Open to BCAPL and USAPL League Players with 4 weeks of sanctioned play between June 1 and August 28, 2015 or who were eligible for the 2015 BCAPL/USAPL National Championships. Both Team Divisions are 8-Ball, double elimination.

Men's Teams:

Begins Sunday, Sept. 6 at 10 am / \$1,500 added based on 32 teams

Women's Teams:

Begins Sunday, Sept. 6 at 10 am / \$500 added based on 16 teams

Team Makeup: The Men's Teams are 4-player and Women's Teams are 3-player teams with up to 7 or 6 maximum players listed on the team roster. Players may only be listed on one team. Each team may have a mix of Leisure, Open, Advanced and Master level players but may only have at most (1) Master or a mix of (2) Advanced players listed on the team roster per match round. Open level players must come from the same league. Advanced and Master players must come from the same state as the team. Races are handicapped and based on the below point system determined by the team member's individual level.

Player Rating Points and Races:

The Men's Teams minimum race is 8 and maximum race is 10. Teams race to (8-10) based on the combined points of the 4 players who compete in that match.

The Women's Teams minimum race is 6 and maximum race is 8. Teams race to (6-8) based on the combined points of the 3 players who compete in that match.

Leisure/Open Player = 2 pts

Advanced Player = 3 pts

Master Player = 4 pts

Substitutions: Teams may sub players after the first round. The sub must be of the same or lower level rating as the person being replaced. The team race number remains the same as determined by the initial team lineup for the match.
