Start Times

Events may begin as early as 11 a.m. on the dates listed on the entry form. However, various factors could delay start times. Check the tournament brackets for the exact start time of your match or ask the Tournament Director.

Know Your Match Time & Location!

Matches are not announced at the event. You are responsible to know when and where your matches are scheduled. Please review Appendix A – Using CTS (CueSports Tournament System). If you still need help, please ask our staff at the Tournament Director's desk.

Match Conflicts

Participants are free to register for other overlapping events held during the US Open 10-Ball & 8-Ball Championships. However, CSI will not schedule around match conflicts with other events. If a match conflict occurs, the player must forfeit one of the matches without refund.

Dress Code

The following dress code will be STRICTLY enforced.

Approved Clothing (both men and women):

- Dress pants or casual slacks.
- Polo or button down style shirt with sleeves, fold over collar or UTG collar. Button down shirts may be worn unbuttoned if they are worn with a neat and tasteful undergarment. Button down shirts worn without an undergarment may only be unbuttoned one button below the neck button. Shirts should not be excessively loose or revealing.
- All footwear must have a closed toe and be normal in its style and wear. Shoes with laces must have the laces properly tied. Dark color tennis or walking shoes are acceptable.

Prohibited Clothing:

- Athletic wear of any kind, including but not limited to: sweats, swimwear, jogging suits, uniforms or jerseys, any kind of pants with contrasting stripes not associated with formal wear.
- Shorts of any kind, regardless of apparent length. Pants must be normal in respect to the appropriate rise in relation to the length of garment and may not be excessively baggy or loose fitting.
- Overalls, coveralls, jeans, hats, headphones or ear pieces (unless medically needed)
- Commonly worn outerwear while on the tournament floor.

Sponsor Logos and Patches:

Players are entitled to wear logos on playing apparel ("player's logos"). Each logo may not exceed 3" x 2" or 6 square inches. The player shall submit to CueSports International (CSI) before his first match examples of all player or player sponsor logos for approval. CSI will have authority to disallow any player or player sponsor logos should they not comply with the policy or conflict with any sponsor or broadcaster of the event. Furthermore, CSI reserves the right to require the player to display a logo on the player's apparel for the use by an event sponsor.

Final Authority

CueSports International has sole discretion and final judgment in all matters regarding the dress code.

EVENTS (OPEN / PRO)

These following events are open to men and women of all skill levels.

US Open 10-Ball Championship / US Open 8-Ball Championship

These events will be held at Griff's Las Vegas. No BCAPL or CSI membership is required. These are modified double elimination events and the races are listed on the entry form. Each entry includes \$500 toward the prize fund. The remainder is admin and greens fees.
