## HIGHLIGHTS

#### CSI Group Play Format for Teams – TEAMS GUARANTEED 5 MATCHES\*

The team divisions will use the CSI Group Play format. Stage 1 is a group stage and Stage 2 is a single elimination final bracket. In Stage 1, teams are randomly drawn into 5 separate matches,\* each consisting of 15 racks for 5-player teams or 9 racks for 3-player teams. The teams that perform the best advance to Stage 2. All matches are handicapped using FargoRate. See the "Teams" section of this Player Guide for more detail.

\* Excluding factors beyond the control of the CueSports International such as forfeits, drop-out teams, no-shows, byes, etc.

#### 9-Ball Teams Division Added

To offer even more team play, we have added the 9-Ball Teams division. 9-Ball Teams will be 3-player teams using the CSI Group Play format. See the "Teams" section of this Player Guide for more detail on this division.

#### Singles & Scotch Doubles Match Times Extended to Two (2) Hours

In the past, singles and scotch doubles matches have been scheduled for 90 minutes. While most matches complete within 90minutes, many do not. When this happens, subsequent matches, and ultimately the entire tournament, gets delayed. Therefore, we are now scheduling singles and scotch doubles matches for two (2) hours to allow more time for everyone and ensure a better experience. For any matches that still do not complete on time, CSI delayed progress rules, which can be found in the CSI Tournament Regulations, will be strictly enforced.

#### Format Change for Singles & Scotch Doubles Divisions

We want everyone to have the opportunity to play in as many divisions as possible. To do that efficiently, it is important to complete one division before the next one begins. The end of a double elimination bracket takes too much time to complete for just a small number of people, causes match conflicts, delays, and frustration for everyone. For example, when there are only four people remaining, it can take eight more hours to finish. To accommodate the growth of the event and still provide everyone the opportunity to play in multiple divisions, the format of all singles and scotch doubles divisions will be slightly modified. The format will be double elimination down to the prize money rounds and then switch to single elimination. This will still allow plenty of play for everyone while also completing the divisions in a timely manner.

#### Second Chance Divisions

Second chance divisions will be offered for all divisions. The start times, format, entry fee, and other details will be announced at the event.

#### **Mini-Tournaments**

Mini-tournaments will be conducted throughout the event based on demand and table availability.


#### **Free Vegas Entries**

The winning team of each team division with eight (8) or more teams will receive free entry into the 2025 BCA Pool League World Championships or USA Pool League National Championships (whichever is appropriate for the winning team). It features 4.5 inch perfectly flush pockets, ultra-black matte fingerprint resistant finish, pocket sound dampening, tracks that prevent chalk from getting stuck in the table, and a ball return system designed to be quiet and keep the balls clean. Its 25mm one-piece pure Brazilian slate, overbuilt frame, and composite legs, each capable of supporting the entire weight of the table, boasts strength and stability.

## **GENERAL INFO**

The purpose of this document is to provide the necessary information about the event and its divisions. This document is not intended to convey the procedures that must be followed at the event.

#### Important Dates

Dec 31: Last day to get qualifiedApr 15: Last day for early entry discountApr 22: Last day for mailed entries & personal checksApr 27: Last day for hotel discount

#### **Refunds & Changes**

Refund requests must be received in writing by email or postal mail by May 6, 2024, and will be processed after May 31, 2024. Admin fees are non-refundable and an additional \$20 processing fee applies to each entry refunded. Change requests must also be received by May 6, 2024, and a \$20/player processing fee applies to each change.

#### Safety Rules

Although it is impossible to predict exactly what restrictions may be in place at the time of the event, players should be prepared to adhere to all safety rules & regulations put into place by CueSports International, Ho-Chunk Gaming, Wisconsin state government or local ordinances. Face coverings, social distancing and temperature checks are just a few examples of possible safety precautions that could be in effect. Players accept this when they register and refusal to follow safety rules and regulations is not sufficient justification for a refund.

#### **On-Site Registrations**

On-site registrations must be cash in US currency. Please note that on-site registrations are not accepted for any of the main divisions.

#### **Event Fees**

Admin fees help cover the cost of processing registrations, verifying eligibility, verifying ratings, etc. Late registrations create a backlog, require extra personnel, and cause increased labor cost. On-site registrations require extra event staff and even more labor costs. Because admin fees are consumed during the registration process, they are non-refundable. Admin fees are included in the entry fees and are as follows:

Green fees help cover the cost of the venue, equipment, staff, set-up, tear-down, etc. Green fees are refundable if a written refund request is submitted prior to the refund request deadline. Green fees are included in the entry fees and are as follows:

**Change fees** help cover the cost of processing changes such as removing players from teams, adding players to teams, verifying the eligibility of new players, verifying the ratings of new players, etc. The change fee is \$20/change. We encourage you to be confident about your registration before submitting it to avoid change fees.

#### Digital Membership Card & Valid Photo ID Required

All participants must have their digital membership card and valid Government-issued photo ID and present it to all opposing players, teams, or staff upon request. Your digital membership card can be found in your personal profile on the FargoRate mobile app which can be downloaded free for Android and Apple devices. Please download the FargoRate app and have your digital membership card ready to show upon request. Failure to show your digital membership card and valid Government-issued photo ID can result in automatic disqualification and forfeiture of entry fees and prize money.

#### Dress Code

All events will follow CSI Dress Code C unless otherwise specified. Team shirts are encouraged but not required.

#### FargoRate

FargoRate has replaced the outdated systems of subjectively classifying players as Open-Advanced-Master, A-B-C, 3-4-5, etc. Players with at least 200 games of data in the FargoRate system have an established rating. Those with fewer than 200 games have a preliminary rating based on any data in the FargoRate system and a starter rating assigned by CueSports International (CSI).

**Example**: John has a Fargo Rating of 593 based on just 50 games. He was assigned a starter rating of 560 by CSI. John's preliminary rating would be calculated by a proportional combination of the two numbers ( $593 \times 25\%$ ) + ( $560 \times 75\%$ ). Therefore, John's preliminary rating would be 568. Starter ratings may be adjusted by CSI at any time.

#### **Rating Reviews**

We carefully review the ratings of all players who register. This process takes time and **we reserve the right to adjust starter ratings and correct errors at any time.** To avoid late rating issues, we encourage you to register early and make sure your rating and your teammate's ratings reflect actual skill level. **Any type of rating correction is not grounds for a refund.** 

**REGISTER EARLY:** You may register at any time. There is no need to wait until you actually have an active membership or reach the minimum weeks of play requirement (discussed later) to register. Players who are not current members but intend to play in a BCA Pool League or USA Pool League later in the year may register now by submitting a paper or PDF entry form which can be downloaded from the <u>official webpage</u>. These registrations will be processed and reviewed at a later date to verify membership status and weeks played.

#### **Rating Penalties**

Each division has a team and/or individual rating cushion to allow for natural rating increases after registration. If a rating naturally increases beyond the cushion, game penalties may be applied. If a player or team has incurred a game penalty, the opponent will race to one game less. If both teams in a match have been penalized, the penalty in that match will be the difference between the two penalties. For example, if Team A has a one-game penalty and Team B has a two-game penalty, Team B will incur a one-game penalty in that match. If both teams have a one-game penalty, there will be no penalty. **Please Note**: The rating cushion applies only to ratings that have naturally increased as a result of additional FargoRate data. A change or correction of a starter rating is not a natural increase.

#### Don't Get Disqualified

We take player ratings very seriously. A player who intentionally enters an event with a rating that is too low for his or her ability, is cheating. Be aware that we have tools in place to monitor players who are consistently and significantly performing above their rating during the event. We reserve the right to disqualify any player without refund. Don't get disqualified. If you believe you are underrated, contact CSI prior to the registration deadline.

#### Ladies Events

While ladies' divisions are offered, FargoRate provides the opportunity for ladies to compete on a level playing field against men. A lady rated 450 plays at the same level as a man rated 450. Therefore, ladies are welcomed and encouraged to participate in all divisions.

#### Verify Your Registration!

The complete list of players can be found near the bottom of the official event webpage. All upcoming events can be found at <a href="http://www.playcsipool.com/events">www.playcsipool.com/events</a>.

If you have already registered for the event, please verify that your name appears in the "Awesome Participants" list in every division for which you registered. Technical glitches can happen and **it's your responsibility to confirm your registration(s)** prior to the event. If you are not on the participant list and you fail to notify us at least one week prior to the event, we may not be able to accommodate you. If your name does appear on the list, it's a good idea to take a screenshot and keep it with you as back-up if needed. It is not helpful to show up at the Tournament Desk and simply say that your name was previously on the list.

#### Start Times & Format

Divisions may begin as early as the times listed in the sections below. However, various factors could delay start times and a delayed start is not grounds for a refund. Always check the tournament brackets at <u>www.ctsondemand.com</u> for the exact start time of your match or ask the Tournament Desk.

#### Plan Your Travel Carefully

Allow plenty of time before, during, and after the event for travel. CSI is not responsible for travel delays, traffic jams or any other travelrelated issue that could cause you to miss your match and be forfeited. Matches are not delayed or accelerated to accommodate travel issues. Therefore, you are encouraged to arrive the day before your division(s) begin and leave the day after the event ends.

#### How to Avoid Forfeits

Each year, people forfeit matches because they do not follow the correct procedures. **Matches are not announced at the event** and there may be occasions when your table is not available at the scheduled time because earlier matches are running late. You are responsible to be at your assigned table when it becomes available. Please review Appendix A – Using CTS (CueSports Tournament System) and the CSI Tournament Regulations. These documents detail the process of avoiding forfeits. If you still need help, please ask the Tournament Desk. Being forfeited as a result of not following the correct procedures (see the Golden Rule below) is not grounds for a refund or a credit.

Golden Rule: If you are at your assigned table at the scheduled match time and do not leave, you cannot be forfeited.

#### Match Conflicts

You may want to play in as many divisions as possible to get the most out of the experience. Therefore, participants are free to register for divisions that overlap. However, CSI is only able to schedule around some of the overlapping divisions as noted in the table below. If match conflicts occur that are not specified in the second column below, the player or team must forfeit one of the conflicting matches without refund.

#### Payouts

Payouts will be made electronically. To receive a payout, you must provide a valid email address. You will then receive an email, usually within 24 hours, from our secure third-party partner (Prize Payments). Follow the onboarding instructions to create an account and complete the required tax information. You will then be able to monitor the delivery status of your payout. Payouts are usually received 24-48 hours after you complete all required information. Payouts may be claimed up to 90 days beyond the last day of the event. Payouts not claimed within the 90-day period will not be processed.

#### **Team Payouts**

One (1) payment will be made to one (1) person for the entire team payout. The person receiving the payment should document the prize money he or she distributes to others for tax purposes.

#### Player Agreement

These terms set forth the legally binding rules for participation in the event. By registering, you agree to be bound by all terms and conditions set forth by CueSports International (CSI). If you are under the age of 18, you agree to obtain the consent of your legal guardian to participate under these terms.

You acknowledge that you have read and completely understand the latest edition of the Player Guide, Entry Form, Tournament Regulations and/or all rules and regulations and you will check for the latest edition of all documents just prior to the event start date. You agree to abide by all rules & regulations implemented by CueSports International (CSI). CSI reserves the following rights and responsibilities: determine a player's eligibility, refuse entry to anyone for any reason, change field sizes, adjust ratings, display names and ratings online, change schedules & payouts based on, but not limited to, field sizes, inclement weather, acts of God, war, or terrorism.

You understand that there is an inherent risk of exposure to COVID-19 and other illnesses when you participate in any event where people are gathered. Although it is impossible to predict exactly what safety restrictions may be in place at the time of the event, you agree to adhere to all safety rules & regulations put into place by CueSports International, Ho-Chunk Gaming, Wisconsin state government or local ordinances. You understand that your participation in this event is completely voluntary. By participating, you further release all media and appearance rights to CSI to produce televised matches, recorded or broadcast at the event and for all photographic images taken at the event. By registering, you agree that CSI may also add your email address to its email list and send you periodic emails at its sole discretion.

## SCOTCH DOUBLES

Check-in is not required for scotch doubles divisions. However, it is your responsibility to know when and where you play.

#### Eligibility

- Teams may consist of male/male, male/female or female/female.
- Both teammates must have been members of a BCA Pool League or USA Pool League **during the 2023 league year** (which ends Dec 31, 2023) and played a minimum of four (4) full scheduled weeks in a single division session during the 2023 calendar year.

  - o Your USA Pool League membership status can be checked at <u>www.playcsipool.com/usapl-membership-lookup</u>
- No person (male or female) may be rated higher than 720 at the time of registration.

#### Team Rating Increases

There is a 20-point team rating cushion. If a team is eligible for a specific division at the time of registration, but one or more members' ratings naturally increase to push them over the limit plus the cushion, it has the following options:

Option 1: Replace one (1) player to get back within the division limit (must still meet all other eligibility requirements)

Option 2: Play and accept a one-game penalty in each match for every 50 points over the cushion

**Example:** A Scotch Doubles team is below the 1,100 limit at the time of registration but their rating naturally increases to 1,118 (18 pts. over the limit) – there is no penalty in the match because it did not exceed the 20-point team rating cushion. If their rating naturally increases to 1,152 (32 pts. over the cushion), they will incur a one-game penalty in each match.

#### Individual Rating Increases

There is a 10-point individual rating cushion. If a person is rated 720 or lower at the time of registration, but his or her rating naturally increases over the limit plus the cushion, the team has the following options:

- Option 1: Replace the player (must still meet all other eligibility requirements)
- Option 2: Play and accept a one-game penalty in each match for every 25 points over the cushion

**Example**: A player has a rating of 717 at the time of registration but it naturally increases to 735 afterwards (5 pts. over the cushion), the team will incur a one-game penalty in each match. If the same player's rating increases to 758 (28 pts. over the cushion), the team will incur a two-game penalty in each match.

2. Races are handicapped based on FargoRate. The first number is that of the double elimination stage and the second is that of the final single elimination stage. For example, if a race is indicated as R4/R5 Hot, it will be an R4 Hot race in the double elimination stage and an R5 Hot race in the final single elimination stage.

3. Each entry includes admin & green fees. See the General Info section for a breakdown of those fees.

4. If Scotch Doubles does not conclude before the start of 8-Ball Singles, it may be necessary to delay the remaining Scotch Doubles matches as some of the remaining players may be competing in both divisions. Therefore, the conclusion of Scotch Doubles may be delayed.

5. The team's combined rating may not exceed 1,100 at the time of registration. Teammates do not need to be from the same league.

6. Teams that have been eliminated may register for Second Chance Scotch Doubles at the Tournament Desk. The format will be single elimination and handicapped by FargoRate. All other details will be announced at the event.

## SINGLES

Check-in for singles divisions is not required. However, it is your responsibility to know when and where you play.

#### Eligibility

- All players must have been members of a BCA Pool League or USA Pool League during the 2023 league year (which ends Dec
  - 31, 2023) and played a minimum of four (4) full scheduled weeks in a single division session during the 2023 calendar year.
    - o Your BCA Pool League membership status can be checked at <u>www.playcsipool.com/bcapl-membership-lookup</u>
    - o Your USA Pool League membership status can be checked at <u>www.playcsipool.com/usapl-membership-lookup</u>
  - Ladies divisions are open to ladies only. All other divisions are open to male and female players.
- For Ladies divisions, no lady may be rated higher than 660 at the time of registration. For all other divisions, no person may be rated higher than 720 at the time of registration.

#### Individual Rating Increases

There is a 10-point individual rating cushion. If a person is rated 720 (660 for Ladies Singles) or lower at the time of registration, but his or her rating naturally increases above 730 (670 for Ladies Singles), he or she has the following options:

Option 1: Move to another division (if possible) and pay any difference in entry fees

Option 2: Play and accept a one-game penalty in each match for every 25 points over 730 (or 670)

**Example**: A player has a rating of 717 at the time of registration but it naturally increases to 735 (5 pts. over the cushion), he or she will incur a one-game penalty in each match. If his or her rating naturally increases to 758 (28 pts. over the cushion), he or she will incur a two-game penalty in each match.

NOTE: Although matches are handicapped, there is a minimum race to 3.

2. After registration ends, the field will be split into multiple divisions based on players' Fargo ratings, approximate percentages shown and the bracket sizes. The percentages shown are approximations and are subject to change based on the skill levels of the participants and bracket sizes.

3. Races are handicapped based on the indicated FargoRate race chart. The first number is that of the double elimination stage and the second is that of the final single elimination stage. For example, if a race is indicated as R5/R6 Hot, it will be an R5 Hot race in the double elimination stage and an R6 Hot race in the final single elimination stage. Although matches are handicapped, there is a minimum race to 3.

4. Each entry includes admin & green fees. See the General Info section for a breakdown of those fees.

5. If 10-Ball Singles does not conclude before the start of 8-Ball Singles, it may be necessary to delay the remaining 10-Ball Singles matches as some of the remaining players may be competing in both divisions. Therefore, the conclusion of 10-Ball Singles may be delayed.

6. If there are at least 180 players registered for 8-Ball Singles, the field will be split into three (3) divisions as shown. If there are less than 180 players registered, the field will be split into two (2) divisions.

7. Open to ladies only. All ladies must be rated 660 or lower at the time of registration.

8. Players who have been eliminated from any of the 10-Ball Singles divisions may register for Second Chance 10-Ball Singles at the Tournament Desk. The format will be single elimination and handicapped by FargoRate. All other details will be announced at the event.

9. Players who have been eliminated from any of the 8-Ball Singles or Ladies 8-Ball Singles divisions may register for Second Chance 8-Ball Singles at the Tournament Desk. The format will be single elimination and handicapped by FargoRate. All other details will be announced at the event.

## TEAMS (CSI Group Play format)

#### Team Check-In & Rosters

Team check-in is required and begins at noon on Friday, May 17. The Team Captain or League Operator must check in at the Tournament Desk prior to the start of the division and obtain an official team roster. Roster change requests must be requested in person by 5pm, Friday, May 17, and final league standings and/or other documents may be required. Roster changes are limited to adding substitutes only and may not result in the team moving into another division. The official roster and valid Government-issued photo ID of all players must be presented to all opposing teams and event staff upon request. Team Captains are responsible for team rosters and there is a \$10 charge for reprinting them.

#### **Team Shirts**

Team shirts are encouraged but not required.

#### Eligibility

- All players must have been members of a BCA Pool League or USA Pool League **during the 2023 league year** (which ends Dec 31, 2023) and played a minimum of four (4) full scheduled weeks in a single division session during the 2023 calendar year.

- For Ladies Teams, no lady may be rated higher than 660 at the time of registration. For all other divisions, no person (male or female) may be rated higher than 720 at the time of registration.
- Players may not be on more than one team roster.

#### Core Roster & Substitutions

The "core" roster is used to determine the total team rating. Players designated as substitutes may not replace a lower-rated core player during competition. Once the deadline for change requests has passed, only subs can be added to the roster. There can be no changes to the "core" roster after the change request deadline.

#### **Team Rating Increases**

There is a 10-point per core player team rating cushion. If a team is eligible for a division at the time of registration but one or more members' ratings naturally increase to push them over the limit plus the cushion, it has the following options:

- Option 1: Move up into the next division (if possible) and pay any difference in entry fees
- Option 2: Replace one or more players to get back within the division limit (must still meet other eligibility requirements)
- Option 3: Play and accept a one-game penalty in each match for every 50 points over the cushion

**Example**: A 5-player team is below the 2,900 limit at the time of registration but their team rating naturally increases to 2,993 (43 pts. over the cushion). They will incur a one-game penalty in each match. If their rating naturally increases to 3,027 (77 pts. over the cushion), they will incur a two-game penalty in each match.

#### Individual Rating Increases

There is a 10-point individual rating cushion. If a person (male or female) is rated 720 or lower, or a female is rated 660 or lower in Ladies Teams, at the time of registration, but his or her rating naturally increases above 730 (Teams) or 670 (Ladies Teams), the team has the following options:

- Option 1: Replace the player (must still meet other eligibility requirements)
- Option 2: Play and accept a one-game penalty in each match for every 25 points over the cushion (730 or 670)

**Example**: A male has a rating of 716 at the time of registration but it naturally increases to 735 (5 pts. over the cushion), the team will incur a one-game penalty in each match. If the same person's rating increases to 758 (28 pts. over the cushion), the team will incur a two-game penalty in each match.

#### Format (CSI Group Play...powered by FargoRate)

The team divisions use the CSI Group Play format consisting of a **Stage 1 – Group Stage** and a **Stage 2 – Single Elimination Final Bracket**. See below for the specific details of each stage.

- the blue button until "1 POINTS" is displayed, enter "3" into the field for "Number of games a player plays per round (or per match if handicapping matches)," and click the "CALCULATE" button. The result will be the handicap per match.
- Teams that forfeit any Stage 1 match are not eligible to be selected as a wild card team for Stage 2.
- 3. Each match is handicapped by FargoRate. If a match ends in a tie score, each team receives 0.5 win points.
- 4. If two or more teams have the same win/loss record, the team that has a higher average performance margin will be ranked higher. The performance margin is a comparison of what a team is expected to score vs what it actually scores in each match. Winning more racks increases your team's performance margin.
- 5. Strength of schedule is the average rating of opposing teams' core rosters. If two or more teams have the same match win % and the same average performance margin, the team(s) with the larger strength of schedule will be ranked higher.
- 6. The cue ball is placed behind the head string and each core player, or eligible sub, for each team shoots alternating spot shots. The team with the most shots legally pocketed after all players have taken a shot, wins the shootout. If tied after all players have shot, it is sudden death.

\* Excluding factors beyond the control of the CueSports International such as forfeits, drop-out teams, no-shows, byes, etc. If a team receives a bye or a forfeit, they receive a match win (1.0 match win points). Their other stats are unaffected.

#### CSI Group Play Stage 2 Advancement Table

1. This is the range of the total number of teams that will advance to Stage 2. No more than 50% of the field will advance to Stage 2.

2. This is the number of wild card teams that will be randomly selected for Stage 2. It is a minimum of one (1) and a maximum of 7% of the total number of Stage 2 teams. Teams that have forfeited any Stage 1 match are not eligible to be selected.

**Example:** There are 92 teams in a division. Refer to the row that contains 92 in the first column (66-129). The table shows that the Stage 2 bracket will be a 64-team bracket. Because a max of 50% of teams advance, 46 teams will advance to Stage 2, Because a maximum of 7% of those 46 teams will be random wild cards, there will be three (3) random wild card teams and 43 teams based on performance. The top 16 teams will earn prize money.

- Total Teams to Stage 2: 92 total teams x 50% = 46 teams
- Wild Card Teams: 46 teams x 7% = 3.22. Since 7% is the maximum, this rounds down to 3 wild card teams.
- Teams by Performance: 46 total teams 3 wild card teams = 43 teams by performance
- Teams to Win Prize Money: 92 total teams x 25% = 23. Because bracket sizes are 2, 4, 8, 16, 32, 64, etc., This rounds down to 16 teams.

4. If there are at least 150 teams registered for 8-Ball Teams, the field will be split into three (3) divisions as shown. If there are less than 150 teams registered, the field will be split into two (2) divisions.

5. Open to ladies only. All ladies must be rated 660 or lower at the time of registration.

6. Teams that do not advance to Stage 2 may register for Second Chance 8-Ball Teams at the Tournament Desk immediately after the Stage 2 teams are posted. The format will be single elimination and handicapped by FargoRate. All other details will be announced at the event.

### **MINI-TOURNAMENTS**

We may conduct mini-tournaments beginning on the first day of the event and will conduct as many as demand and table availability allows. Many different formats may be offered such as handicapped, non-handicapped, 8-ball, 9-ball, 10-ball, etc. Those wishing to participate should visit the Tournament Desk.

#### Eligibility

- Member of a BCA Pool League or USA Pool League **during the 2023 league year** (which ends Dec 31, 2023) and played a minimum of four (4) full scheduled weeks in a single division session during the 2023 calendar year, <u>or</u>
- 2024 CSI Member (\$40/year). Please note that a \$20 green fee is due at the time of registration.

NOTE: Some mini-tournaments may have specific rating, gender, league, and misc. requirements.
