Standard Entry: Must be made online, postmarked, faxed, or emailed by May 11th. All entries include a \$15 registration fee and \$10 green fee.

Late entries: Late fees start May 12th. All entries mailed or faxed on or after May 12th must include a \$10 late fee.

Entry deadlines: Must be postmarked by May 18th. Entries made online, faxed, or emailed must be received by May 25th.

On-Site Entries – All on-site entries (if available and fields are not full) must include a \$10 late fee. All on site entries are non-refundable!

NO CHECKS accepted after May 11th. **NO EXCEPTIONS!** **ALL EVENTS - NO TRANSFERRING OF ENTRIES !!**
